The preferred candidate will possess a Medical Doctor (MD) or Doctor of Osteopathy (DO) degree or graduation from a foreign medical school and certification by the Educational Commission for Foreign Medical Graduates (ECFMG) or equivalent. The incumbent is responsible for admitting, evaluating, diagnosing, and treating adult patients, but are not limited to prescribing medications, ordering diagnostic and laboratory tests. The incumbent will support the mission of NMSH to provide the highest quality acute psychiatric care for Northeast Mississippi adults in the process of recovery.

Essential Functions:

The incumbent provides professional medical services and administrative duties in Psychiatric health activities for the Department of Mental Health. Teamwork is involved with Nurse Practitioners, Nurses, MH-Active Treatment Technicians, and the Clinical Director. Ability to communicate orally and in writing with other DMH facilities and State Agencies. Incumbents' work is overseen by the Clinical Director.

- Admit, evaluate, diagnose, treat, and provide consultation to adult patients who suffer from mental, behavioral, addictive, or emotional disorders.
- Provide consultation with physicians in other fields regarding mental, behavioral, or emotional disorders and their interaction with physical disorders.
- Prepares and keeps necessary records and reports as may be indicated.
- Prescribes medications. Orders diagnostic and laboratory tests.

Experience/Educational Requirements:

Education: Graduation from an accredited school of medicine with a Medical Doctor (MD) or Doctor of Osteopathy (DO) degree, or graduation from a foreign medical school and certification by the Educational Commission for Foreign Medical Graduates (ECFMG) or equivalent;

Successful completion of a psychiatry residency program which is accredited by either the Accreditation Council for Graduate Medical Education (ACGME) or the American Osteopathic Association (AOA), and Certification/Licensure/Registration/Documentation as required below.

Certification, Licensure, and Registration:

Holds a current and unrestricted license to practice medicine as a physician in the State of Mississippi; **AND**

Previous or current eligibility to become Board Certified, or is Board Certified in Psychiatry;

AND

Registered and certified by the Drug Enforcement Administration (DEA).
